## OFFICE MEMORANDUM

Subject:- Filling up the posts of Senior Legal Assistant (SLA) on deputation basis, in different benches of National Company Law Tribunal (NCLT).

Applications are invited for filling up the following posts of Senior Legal Assistant (SLA) on deputation basis in New Delhi, Ahmedabad, Allahabad, Amravati, Bengaluru, Chandigarh, Chennai, Cuttack, Guwahati, Hyderabad, Indore, Jaipur, Kolkata, Kochi, Mumbai National Company Law Tribunal (NCLT) Benches.

- 2. The details of the posts, along with eligibility criteria, educational qualification, experience etc. required for each category of post are given in the enclosed Annexure-L. The National Company Law Tribunal (Recruitment, Salary and other Terms and Conditions of Service of Officers and other Employees) Rules, 2020, may kindly be seen at NCLT website, i.e., here a subsequent under the link career.
- 3. The period of appointment on deputation will be initially for a period of three years or till further orders, whichever is earlier. Other terms and conditions of service shall be governed by O.M. No. 6/8/2009-Estt..(Pay II) dated 17th June, 2010 of Department of Personnel & Training, Ministry of Personnel Public Grievances & Pensions, Govt. of India, as amended from time to time.
- 4. The officers and staff joining/already joined in NCLT on deputation, and already availing GPRA facility in their parent body, have been allowed to continue the benefit of GPRA on joining NCLT. However, the officers and staff not already availing GPRA in their parent body will not be eligible to apply for General Pool Residential Accommodation on joining NCLT on deputation.
- 5. Maximum age limit for appointment on deputation to the above posts is 56 years as on the closing date of receipt of applications.
- 6. Application in the prescribed proforma (Annexure-II) complete in all respect along with the certificate attached to the application from the employer/head of
